GENERAL INFORMATION:

Objective of the award: The California Association of Toxicologists (CAT) offers an award to promote research and inquiry into toxicology and the sharing of these results with fellow toxicologists. Proposals for the study of the interaction of pharmaceuticals or poisons with physiological systems or projects relating to the practice of analysis and interpretation of drug concentrations in biological specimens are solicited. It is intended to fund projects in the area of clinical and forensic toxicology.

Who qualifies to apply: CAT members or non-members with a CAT member as a sponsor.

How to apply: Follow the attached instructions and direct the application to the Chair of the CAT Research Assistance Grant.

Expenses to be reimbursed: The award will pay approved expenses relating to the research (supplies, materials, services) or expenses involved in travel to scientific meetings for the purpose of presenting results of the research project.

How to be reimbursed: Submit an itemized bill after the presentation at a CAT meeting to the Chair of the Research Assistance Grant. The Grant Chair will forward the bill to the CAT Treasurer for reimbursement. An advance on the proposed budget is possible if the CAT Board of Directors has approved the application. Requests for advance award funding should be made to the Grant Chair.

When to apply: All applications will be considered and can be submitted any time of the year. There is no limit to the number of awards granted per year.

Application approval: There must be time for the CAT Board of Directors to consider the application prior to the announcement of the award at the next quarterly meeting. The deadline for consideration by the Board will be two months prior to the date of any upcoming quarterly meeting. The application will be distributed to all of the Board members by the Grant Chair. It is not necessary to convene the Board, but two-thirds of the elected Board members must approve the award application.

Project completion deadline: There is an expectation that the project will be completed in a timely fashion. Extensions may be requested if the project is expected to take longer than a year. Recipients of the award are expected to present their findings at a future CAT meeting and the findings are to be published in the CAT newsletter. Submit a summary of the research project to the Secretary of Proceedings for inclusion in the next CAT Newsletter within two weeks of the presentation.

Current award amount: The California Association of Toxicologists has made available \$2,500. In addition, up to \$500 is available for travel expenses to recipients of the award who will be expected to present their findings at a future CAT meeting. (Speakers should register, but are not to be charged a registration fee for the day of their presentation at the CAT meeting.)

Application form: Instructions are included in the application form on pages 3 to 6. Please complete each section of the form.

Biosketch of applicant (and sponsor): The applicant and sponsor (if applicable) must submit a biosketch with the application. It should include:

1. Education
2. Experience
3. Membership in Professional Organizations
4. List of publications and presentations (if applicable)
